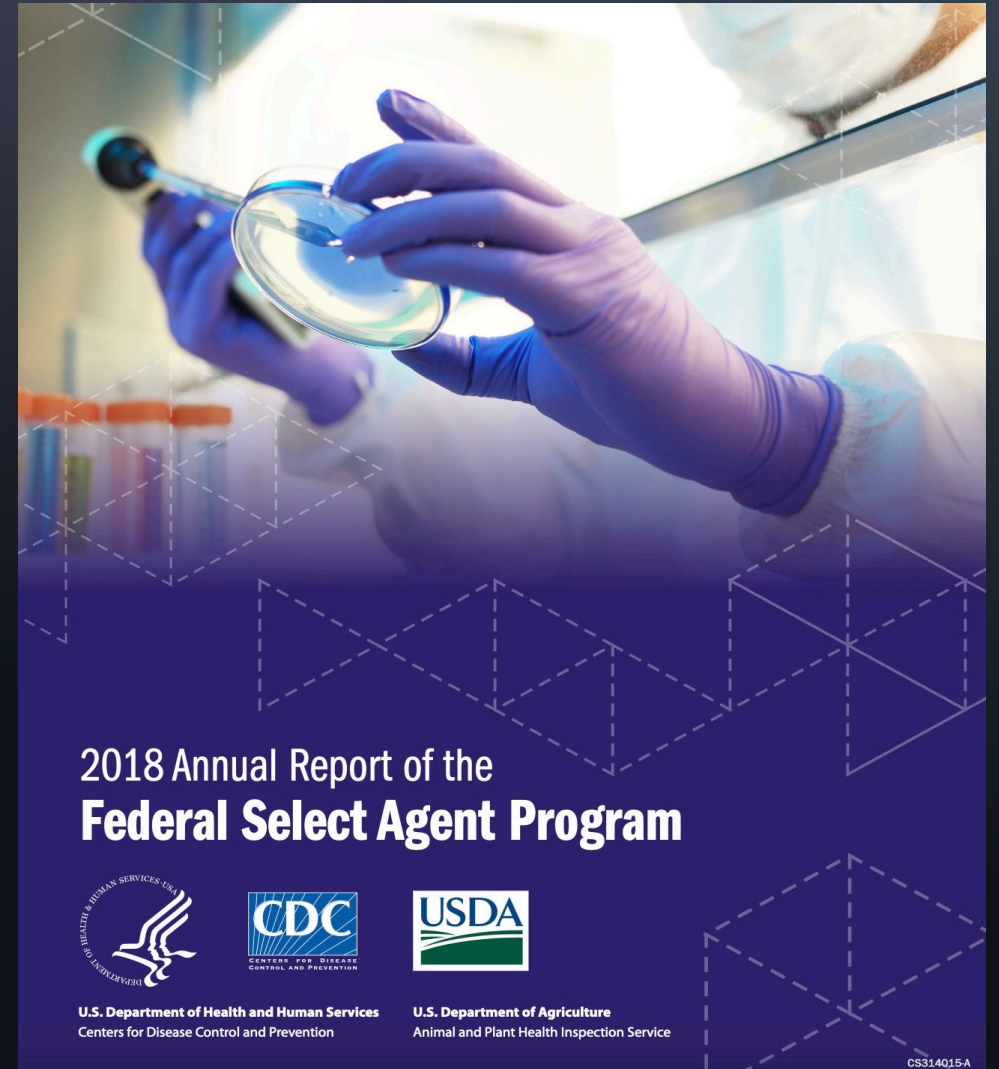
1. If the WHO really wanted to solve the problem of pandemics and biological warfare, **it could but it didn't**: strengthened the biological weapons convention of 1972, banned so-called gain-of-function research, and not incentivize the search for, sharing, and research into PPPs
- 2. The WHO is not an honest broker**; it repeatedly attempts to fool us
3. The effort to wrest sovereignty from nations under the guise of health is not simply a WHO effort: it is also the effort of the **UN**, the **EU**, the **G20**, the **World Bank**, the 2023 **NDAA/ IPP**



'Preparedness' is very risky!

- CDC and USDA run a Select Agent program for selected US Potential Pandemic Pathogens
- There are **200 accidents per year** reported to CDC re: select agents
- In 2018 alone, 173 (of 201 reported) releases led to "**895 individuals [receiving] occupational health services, including medical assessments and, if needed, diagnostic testing and prophylaxis.**"

3. The Parties commit to establishing, or building on existing, genomics, risk assessment, and laboratory networks in order to conduct epidemiological genomic surveillance and the global sharing of emerging pathogens with pandemic potential, and drug-resistant pathogens.

(d) sustained national and/or regional laboratory capacity, including for genomic sequencing, as well as for analysing and sharing such information;

Gain of Function Research is another name for Biowarfare Research. It is defined as studies to increase pathogenicity and transmissibility of microbes. The Treaty/Accord incentivizes GOF and the previous slide demands proliferation (sharing)—which is banned by other laws and treaties

5. Each Party shall implement and apply relevant international standards for the biorisk management of laboratories and research facilities that carry out research to better understand the pathogenicity and transmissibility of pathogens with pandemic potential, and to prevent the unintended consequences of such research, while minimizing unnecessary administrative hurdles for research.

The 2023 National Defense Authorization Act (NDAA (passed Dec 2022) has enshrined in US law a commitment to follow the WHO and use the One Health approach

- **Subtitle D—International Pandemic Preparedness** (pages 950-967)
- We will **comply with the global health security agenda**
- We will advance the **One Health** approach
- We will **fund Gavi**, A Bill Gates vaccine NGO
- We will be part of an **early warning network—though none have ever worked**
- We have the right to send personnel into a hostile country if it refuses to share information about an outbreak—to do what?
- At least \$1 billion a year is allotted for this purpose
- **Proliferation issues that other treaties prevent are ignored**
- **Ways to measure 'progress' in readiness are useless**

The 'need' for pandemic preparedness relies on **FALSE ASSUMPTIONS:** that pandemics are common, very deadly, arise through contact with animals, and that we can anticipate and prevent them

- ✓ The deadly 1918 Spanish Flu occurred before we had antibiotics, antivirals, IVs and ICUs—before modern medicine; **it's unlikely to recur**
- ✓ The **US flu pandemics of 1957, 1968 and 2009** were barely noticeable
- ✓ **SARS-CoV-2 was made in a lab**, and the only question today is whether it escaped accidentally or was deliberately spread
- ✓ **It had nothing to do with viral "spillover"**
- ✓ The Wet Market theory was a cover story to protect the rollout of pandemic preparedness, a.k.a. the Global BioSecurity Agenda
- ✓ **We already know how to deal with pandemics**, and it takes doctors, nurses and basic supplies—not an imaginative network surveilling for and capturing potential pandemic pathogens

Only 3 pandemics occurred during the 20th Century—yet they are occurring nonstop in the 21st Century

20th Century: 1918, 1957, 1968 influenza pandemics, and the last two were barely noticed by the population

21st Century: (and we are only 23 years in)

- SARS (2002-3),
- avian flu (2004-on),
- swine flu (2009-10),
- Ebola (2014; 2018-19),
- Zika (2016),
- COVID (2020-2023),
- monkeypox (2022-23)



And we keep hearing
that the next one
will be worse!
WHY?

Last month, the WHO pulled a fast one—it maneuvered to evade making the final draft of the Amendments public 4 months ahead of the May vote, as required

- **If WHO gets away with this (and there is no one with authority over the WHO to stop them except the WHA) we might not find out what is in the Amendments until after they have been passed.**
- In May 2022, several amendments were passed 'by consensus'—in back rooms—there was no actual vote
- **If the 2024 amendments are passed, we need to seriously consider how to get out from under them**

Lies about pandemic accord endangering future generations: WHO chief

“I need to put this plainly: those who peddle lies about this historic agreement are endangering the health and safety of future generations.”

“WHO will not be a party,” he said

That is because the WHO IS a party to the International Health Regulations, and the amendments now being negotiated require countries to obey the WHO Director-General's directives, including censorship of everything except the WHO's public health messaging, vaccine and mask mandates, vaccine passports, quarantines, and withholding certain medicines during a pandemic.

EU GLOBAL HEALTH STRATEGY

Better Health For All in a Changing World



"As we shift the focus on what to do, an equally fundamental shift must occur on how to do it. **A new global health order is emerging** —and the EU must contribute to shaping it through a more strategic and effective engagement."

"Global governance will require a new focus to maintain a strong and responsive multilateral system, **with a World Health Organization (WHO) at its core** which is as sustainably financed as it is accountable and effective. Consensus should be built through deepened cooperation through G7, G20, and other global, regional and bilateral partners. The EU should drive the essential process of filling the existing gaps in global governance, avoiding duplication and ensuring coherence of action. This will need **close cooperation with the private sector, philanthropic organisations, civil society and other stakeholders** to support this strategy's objectives."

GUIDING PRINCIPLE 9.

Negotiate an effective legally binding pandemic agreement with a One Health approach and strengthened International Health Regulations.

This fills the gaps in the international rulebook for pandemic preparedness and response, requiring countries and empowering the WHO to report and investigate pandemic threats rapidly⁵⁴. The pandemic agreement should include concrete provisions on anti-microbial resistance⁵⁵.

GUIDING PRINCIPLE 10.

Build a robust global collaborative surveillance network to better detect and act on pathogens

The strategy supports the creation of a new reliable network that surveys and detects pathogens in key hotspots, and not only identifies threats but also advises on action to take. This work would be supported by EU Delegations on the ground and complement the G7 initiative connecting existing networks⁵⁶. It will include digitalisation and integration of surveillance systems across the human, animal and environment spectrum, strengthening laboratory capacities and genomic sequencing capabilities, as well as workforce training.



D. Multilateral Institutions for the 21st Century

Reinvigorating Multilateralism


"The need for revitalized multilateralism to adequately address contemporary global challenges of the 21st Century, and to **make global governance more representative, effective, transparent and accountable**, has been voiced at multiple fora. In this context, a more inclusive and **reinvigorated multilateralism and reform aimed at implementing the 2030 agenda** is essential."

The UN proposed its own vague power grab

"We are living in a period of great uncertainty, yet we know that the risks we face are growing and becoming more complex. Enhanced international cooperation is the only way we can adequately respond to these shocks, and the United Nations is the only organization with the reach and legitimacy to convene at the highest level and galvanize global action."

According to the Secretary General, "I propose that the General Assembly provide the Secretary-General and the United Nations system with a standing authority to convene and operationalize automatically an Emergency Platform in the event of a future complex global shock of sufficient scale, severity and reach."

"The Administration looks forward to working with Congress to implement this investment strategy to **save trillions of dollars and millions of lives.**

The Strategy sets out to:

Detect pandemics and other biological threats: The Strategy aims to transform early warning of infectious disease threats by **accelerating the development and deployment of new technologies** that can rapidly detect novel pathogens. It will improve real-time information for decision-making by planning for an **enduring all-hazards hospital data collection system**, expanding platforms to integrate and share data for response, and **improving data sharing internationally**. These efforts build on the recently launched **Center for Forecasting and Outbreak Analytics**, which creates the equivalent of a "national weather service" for infectious disease outbreaks, enabling rapid, effective decision-making to improve outbreak response **using data, modeling, and analytics.**"

One Health, EcoHealth, Planetary Health, and Veterinary Public Health: A Deeper Dive

One Health, EcoHealth, Planetary Health, and Veterinary Public Health are among the terms that have gained traction in the international community as approaches to address health threats and challenges at the human-animal-environmental health interface. The approaches are similar in all, promoting a more thorough and integrated understanding of the links between humans, animals, and/or the environment, including the anthropogenic forces acting on ecosystem dynamics. In addition, each reinforces the importance of collaborating across sectors and broadening the scope of health and its determinants.

Financial Intermediary Fund for Pandemic Prevention, Preparedness and Response

Governance Framework

"COVID-19 has highlighted the urgent need for collective action to augment the existing **global health security financing system** and to mobilize additional, **dedicated resources** to build health systems and **strengthen capacity for pandemic prevention, preparedness, and response (PPR)**. **Avoiding future pandemics requires investing substantially more in PPR**; these investments will help avert the **much larger costs** that the world would incur if we were to be caught unprepared for the **next global health crisis**. Countries must **step up domestic investments** in the core pandemic PPR capacities needed to **strengthen health preparedness and prevent and contain future pandemics, in accordance with the International Health Regulations...**"

Why is the Global Bio-Security Agenda so important to the international power elites?

The suggested IHR Amendments and Pandemic Treaty give them the following:

- 1. A reason for nations to borrow many billions of dollars, spend it on products that profit them, and also earn huge commissions**
- 2. The justification to conduct bio-surveillance, and to collect and decode the genomes of the world's population for potential profit and potential control**
- 3. A reason to require digital vaccine passports/IDs to be followed by digital money, yielding extraordinary profits and total control**
- 4. A reason to interfere with agricultural activities, fishing and food processing in the name of environmentalism and One Health**
- 5. The ability to move populations in order to 'protect' biodiversity and ecosystems**
- 6. The right to impose massive digital surveillance, censorship and the enforcement of a single WHO public health narrative worldwide—yielding ultimate control of information**
