SOVEREIGNTY UNDER SIEGE: EXPOSING THE WHO'S POWER GRAB AND WHAT YOU CAN DO ABOUT IT

Door to Freedom is a new 501c3 organization founded by Ellsworth resident Dr. Meryl Nass to educate the public and government officials about the looming threat to sovereignty posed by the World Health Organization (WHO).

If you liked the powers that governments used on their citizens during the COVID pandemic, read no further--because you will LOVE what the WHO is doing. It is collecting all those powers, and more, and giving them to itself--so the WHO can manage both public health emergencies, as well as anything that might pose a potential risk to public health. Such as climate change, energy use or the foods you eat.

If you don't think giving WHO such broad powers to control your life is a good thing, read on.

These rules already exist in the IHRs, but when the new amendments are in force they will be **binding = obligatory**

Article 18 Recommendations with respect to persons, baggage, cargo, containers, conveyances, goods and postal parcels

1. Recommendations issued by WHO to States Parties with respect to persons may include the following advice:
- no specific health measures are advised;
 - review travel history in affected areas;
 - review proof of medical examination and any laboratory analysis;
 - **require medical examinations;**
 - review proof of vaccination or other prophylaxis;
 - **require vaccination or other prophylaxis;**
 - place suspect persons under public health observation;
 - **implement quarantine or other health measures for suspect persons;**
 - implement isolation and treatment where necessary of affected persons;
 - implement **tracing of contacts** of suspect or affected persons;
 - **refuse entry** of suspect and affected persons;
 - refuse entry of unaffected persons to affected areas; and
 - implement exit screening and/or restrictions on persons from affected areas.

HOW COULD THIS HAPPEN?

The WHO is negotiating 2 documents that will change the organization from a health charity to a global health dictator.

They will be voted on in May 2024.

These documents would give the WHO extraordinary new powers. For example, the WHO now is able to make the following recommendations to countries. If the International Health Regulations (IHR) are amended in May, as planned, the WHO would be able to issue what were recommendations as mandates.

And as if mandatory vaccinations were not bad enough, the WHO is demanding that nations nations put laws into place so that rapidly developed, unlicensed vaccines could be used, liability-free.

The planned amendment to the International Health Regulations (IHR) in May would empower the WHO to enforce recommendations as mandates. This threatens global health governance and national sovereignty.

THE WHO'S PROPOSED TREATY ARTICLE 15

guarantees that manufacturers, governments and the WHO will be protected by "no fault" liability management for "novel" vaccines:

Article 15. Compensation and liability management

1. Each Party shall develop national strategies for managing liability risks in its territory regarding the manufacturing, distribution, administration and use of novel vaccines developed in response to pandemics. Strategies may include, inter alia, the development of model contract provisions, vaccine injury compensation mechanisms, insurance mechanisms, policy frameworks and principles for the negotiation of procurement agreements and/or the donation of novel vaccines developed in response to pandemics, and building expertise for contract negotiations in this matter.
2. The Conference of the Parties shall establish, within two years of the entry into force of the WHO Pandemic Agreement, using existing relevant models as a reference, no-fault vaccine injury compensation mechanism(s), with the aim of promoting access to financial remedy for individuals experiencing serious adverse events resulting from a pandemic vaccine, as well as more generally promoting pandemic vaccine acceptance. The Conference of the Parties shall further develop the mechanism(s), which may be regional and/or international, including strategies for funding the mechanism(s), through the modalities provided for in Article 20 herein.
3. Each Party shall endeavour to ensure that, in contracts for the supply or purchase of novel pandemic vaccines, buyer/recipient indemnity clauses, if any, are exceptionally provided and are time-bound.

The WHO would be able to demand that countries censor their citizens so that only the WHO's narratives on health could be shared.

Censorship was quietly slipped into Article 44 ("Collaboration and Assistance")

Article 44 Collaboration and assistance

2. WHO shall collaborate with **and promptly assist** States Parties, **in particular developing countries** upon request, ~~to the extent possible~~, in:

(e) (New) countering the dissemination of false and unreliable information about public health events, preventive and anti-epidemic measures and activities in the media, social networks and other ways of disseminating such information;

HEALTHCARE HELD HOSTAGE: THE W.H.O.'S POTENTIAL TO RESTRICT ACCESS TO MEDICINES AND SUPPLEMENTS

The WHO could stop you from obtaining the medicines, vitamins or supplements you desire whenever it declares a pandemic or potential pandemic.

Article 43 is where the plan to restrict medications during future pandemics is hidden, using odd language

Article 43 Additional health measures

4. After assessing information and public health rationale provided pursuant to paragraph 3, 3bis and 5 of this Article and other relevant information within two weeks, WHO **shall** make recommendations to the State Party concerned to modify or **rescind the application of the additional health measures in case of finding such measures as disproportionate or excessive.**

The Director General shall convene an Emergency Committee for the purposes of this paragraph.
