## PROTECTING OUR CONSTITUTIONAL RIGHTS AGAINST THE WORLD HEALTH ORGANIZATION'S OVERREACH

In May 2024, critical votes will take place when the World Health Organization (WHO) seeks to expand its authority from an advisory role to directly impacting nations' public health policies.

**The proposed WHO Pandemic Treaty and International Health Regulations (IHR) amendments pose a significant threat to our freedoms, sovereignty, and individual liberties.**

**These rules already exist in the IHRs, but when the new amendments are in force they will be binding = obligatory**

*Article 18 Recommendations with respect to persons, baggage, cargo, containers, conveyances, goods and postal parcels*

Recommendations issued by WHO to States Parties with respect to persons may include the following advice:

- require medical examinations;
- review proof of vaccination or other prophylaxis;
- require vaccination or other prophylaxis;
- place suspect persons under public health observation;
- implement quarantine or other health measures for suspect persons;
- implement isolation and treatment where necessary of affected persons;
- implement tracing of contacts of suspect or affected persons;
- refuse entry of suspect and affected persons;
- refuse entry of unaffected persons to affected areas; and
- implement exit screening and/or restrictions on persons from affected areas.

## Here's What You Need to Know:

**Threat to Sovereignty:** Adoption of these documents would elevate the WHO to a global health governor, eroding national sovereignty and placing vital health decisions in the hands of unelected officials.

**Unlimited Powers:** The proposed amendments grant unprecedented powers to the WHO, replacing the authority of elected representatives, mandating compliance with WHO directives, and expanding WHO's right to declare emergencies that are unrelated to health, such as a climate change emergency.

**Suppression of Rights:** Alarming indications of intent to suppress free speech, establish global surveillance, and collect and share potential biological weapons pose a direct threat to our privacy, freedoms, and way of life.

**Destroys Democracy:** These initiatives bypass democratic processes, undermining democratic principles by granting unchecked powers to unelected and unaccountable officials at the WHO. Transparency, accountability, and meaningful citizen participation in decision-making are imperative.

**Death Blow to the Doctor-Patient Relationship:** The proposed treaties establish a dangerous monopoly on health information, can prevent doctors and patients from accessing the medications of their choice, and require nations to authorize the use of unlicensed, experimental, liability free vaccines--which might then be mandated.

**Secret Negotiations include "Stakeholders":** Lack of transparency and accountability in negotiations, while "stakeholders" like the Bill and Melinda Gates Foundation get a seat at the negotiating table, undermines the integrity of the process.
