



MANDATE OF THE SOVEREIGN PEOPLE OF ECUADOR

Those of us who make up the National Intercultural and Plurinational Citizen Assembly of Ecuador (ANCIPE), through the First Great National Convention in Defense of the Sovereignty of the Republic, Health and Global Wellbeing, held on May 3, 4, and 5 of 2024, in the Vilcabamba Parish belonging to the Loja Canton, Province of Loja, and protected by the following Ecuadorian Constitutional Articles 1, 2, 3, 6, 9, 10, 11 (especially sub-numerals 6 and 9), 32, 61, 66 (especially sub-numerals 23-24-25-27 and 29 literals a and d), 71, 73, 74, 83, 84, 85 (especially numeral 2), 95, 96, 98, 171, 204, 363 (especially numerals 1 and 3), 416 and 422 (first paragraph), of the Constitution of the Republic of Ecuador, WE EXHORT you, Mr. Constitutional President of the Republic of Ecuador, and, through you, all the representatives of your executive cabinet to faithfully comply with the respective requests. of the citizens.

Therefore, the full assembly of the **FIRST CONVENTION** after hearing all the contributions and inputs issued by the attending citizen assembly members, we then debated and agreed to issue the following:

CITIZEN MANDATE

That, as children of the land of middle of the world, millennial heirs of the Andes, and as constituents of this Sovereign Republic, we express to the world that Ecuadorians have been victims of the systematic violation of our human and constitutional rights by part of those who exercise the public function of Ecuador, sheltered behind an alleged pandemic, in clear disregard of what is contemplated in Article 3 of our own Constitution, which obliges the state to guarantee, without any discrimination, the effective enjoyment of our established rights in such document and in international instruments.

That, by the supreme law invoked, absolutely no one can ignore or evade their duties and responsibilities, as categorically expressed in Article 83 of our Constitution, therefore, among our rights also includes the revocation of the mandate of those who do not comply with the law or betray public faith, as established in Article 61 paragraph 6 of the Constitution.

That, it is inadmissible that the administration in power after violating our fundamental rights, discriminating against a sector of the population, preventing access and enjoyment of public and private goods and services, coercing them to be inoculated with an experimental substance in which the administration is not responsible for the adverse reactions, issuing resolutions through a committee without constitutional or legal powers, and, without a decree of state of emergency having been issued. Now the current administration has the intention to sign an agreement behind the backs of the people and the other global health organizations, blatantly violating our Constitution, violently breaking the rule of law.

That, for these reasons, in response to these atrocities against our people, we as **the National Intercultural and Plurinational Citizen Assembly of Ecuador (ANCIPE)**, together with the Local Citizen Assemblies, Collectives, Guilds, Social Organizations present at the First Great National Convention held in Vilcabamba , we sign this

CITIZEN MANDATE protected by what is established in **Articles 84, 85 and 204**, of the Constitution of the Republic of Ecuador.

Art. 84.- *The National Assembly and all bodies with legal and regulatory authority shall be obligated to adjust, formally and materially, the laws and other legal standards related to the rights provided for in the Constitution and international treaties and those that are needed to guarantee the dignity of human beings or communities, peoples and nations. In no case shall amending the Constitution, laws, other legal and regulatory frameworks or actions by the government endanger the rights recognized by the Constitution.*

Art. 85.- *The drafting, enforcement, evaluation and monitoring of public policies and public services that guarantee the rights enshrined in the Constitution shall be governed by the following provisions:*

- 1. Public policies and the provision of public goods and services shall be aimed at enforcing the good way of living and all rights and shall be drawn up on the basis of the principle of solidarity.*
- 2. Without detriment to the prevalence of public welfare over individual well-being, when the impacts of the implementation of public policies or the provision of public goods and services undermine or threaten to undermine constitutional rights, the policy or provision must be reformulated or alternative measures shall be adopted to reconcile the conflicting rights.*
- 3. The State shall guarantee the equitable and mutually supportive allocation of the budget for the implementation of public policies and the provision of public goods and services.*

In the drafting, implementation, evaluation and monitoring of public policies and public services, the participation of persons, communities, peoples and nations shall be guaranteed.

Art. 204.- *The people are the mandator and prime auditor of public power, in the exercise of their right to participation.*

The Transparency and Social Control Branch of Government shall promote and foster monitoring of public entities and bodies and of natural persons or legal entities of the private sector who provide services or carry out activities for the general welfare, so they shall conduct them with responsibility, transparency and equity; it shall foster and encourage public participation; it shall protect the exercise and fulfillment of rights; and it shall prevent and combat corruption.

The Transparency and Social Control Branch shall be comprised of the Council for Public Participation and Social Control, the Office of the Human Rights Ombudsman, the Office of the Comptroller General, and the Superintendencies. These entities shall have a legal status and administrative, financial, budgetary and organizational autonomy.

Therefore we emphasize the following:

Invested in our absolute human dignity as living beings of this planet and originating from this territory, where we were born and/or live, under its laws and social, cultural, civilizational norms, in the Jurisdiction of the Republic of Ecuador, we promulgate our feelings and will, and with the accompaniment of the civil conglomerates of our community, embracing our freedom of expression, with legitimate autonomy, **WE Enunciate :**

1. That **our life and, therefore, our health decisions belong to us** and we are not transferring or assigning rights to third parties to decide on our behalf, which we do not consent to at all.
2. That, we will not allow ourselves to be forced again to be the subject of genetic experiments or anything similar, through vaccines or any other method alleged for human use, even in the event that protocols are complied with. Each citizen has the right to decide to not get vaccinated, or ingest any other therapy and/or substances. We demand informed consent.
3. That, there is no other legal norm to which we owe respect and obedience other than the Constitution of the Republic of Ecuador.
4. That we were born alive and that sovereignty over our body belongs to each individual, and, consequently, we are subscribed to a legal framework in force in Ecuadorian territory.
5. That, we have the power to accept or not any medical procedure in our favor, under strict right of informed consent, enshrined in the Constitution of the Republic of Ecuador and ratified in other International Instruments.
6. That, each of us are sovereign in our body, vital energy, emotions, mind, soul and spirit, therefore:
 - 6.1. We reject any intention of submission to our will and consent, because the power of the State cannot allow itself to violate our personal and individual sovereignty.
 - 6.2. We reject all promotion and dissemination of misleading, distorted and untrue information that generates confusion, fear and misinformation, even more so if it comes from public institutions, authority figures and the media.
 - 6.3. And we demand that these institutions and people adhere to the true intention mandated by the Constitution and refrain from promoting manipulated information, otherwise taking into account the subsequent consequences and responsibilities.
7. That, all of our personal freedoms are inalienable, up to the point of individual self-determination and voluntary adherence to the community to which we belong.
8. That, the Constitution of the Republic recognizes the prevalence of the *ibidem* (in the aforementioned place) laws over any other norm, law, treaty or regulation that undermines and threatens the constitutional rights of food sovereignty, rights of nature, biodiversity, care of water and life in general, from which the rights of the inhabitants in the territory of the Republic of Ecuador emanate.
9. That, we demand compliance with the Constitution of Ecuador regarding the non-interference of foreign military or police forces, as well as the non-linkage of our jurisdiction to foreign individuals or institutions or foreign to the legal nature of the Ecuadorian State, without sovereign authorization. .

10. That, we urge the government of our country to refrain from any form of interventionism or neocolonialism, camouflaged as diplomatic, consular commitment, or binding technical assistance, currently or in the future.
11. That, due to **our natural ancestral rights** and customs of ancestral and integrative medicine, and other respective alternative, complementary therapies, as well as the actions of **indigenous justice** of different nationalities, **we exercise total authority** over our individual being and over our dependent family members, and the resources that legally belong to us, and on the territory where we live. Therefore, we establish the subsequent responsibility that every official carries, personally and institutionally, in the case of any act, intention, plan or mechanism **that violates** the rights that assist us in accordance with the Constitution of the Republic of Ecuador, as **an attack** on our rights.
12. That, we urge that public policies be fulfilled and activated according to the comprehensive model of family, community and intercultural health, for which complementary medicine, ancestral and alternative medicine clinics must be created and promoted in accordance with the provisions of the Constitution of the Republic of Ecuador.
13. That the national organizations and relevant officials **must comply with the comprehensive protection** of personal data and the privacy of the individual against all types of electronic, electromagnetic, digital, computerized devices, and other devices that emit non-ionizing radiation outside the range permitted for good health and as well as others that affect our life vitality and the biometric ecosystem of our cells and our entire organism (body).
14. That, because the Republic of Ecuador unfortunately favors the production and marketing of foods produced or imported containing an excessive amount of pesticides and other components that contaminate the environment and affect our health, we urge that public policies be generated and reinforced that require the use of raw materials, inputs and products free of pesticides and contaminants for the production and marketing of healthy food.
15. That, we declare ourselves in a permanent assembly mode and we invite and convene the Local Citizen Assemblies, Collectives, Guilds, Social Organizations and Citizenship of the entire country, as well as Ecuadorians residing abroad, so that, in the event that this **CITIZEN MANDATE is not acted upon** by the national government, prior to a favorable ruling of the Constitutional Court, a referendum and/or popular consultation of citizen initiative will be called, for which this Great Citizen Assembly held in the city of Vilcabamba provides: **that the The Ecuadorian State refrains from signing the pandemic treaty/agreement and IHR (International Health Regulations) amendments proposed by the WHO, or other transnational organizations** because the people, have not given a referendum, nor authorized the surrender of territorial, food, health, sanitary sovereignty and all stipulated in the Constitution of the Ecuadorian State to a private health entity organization such as the W.H.O. or others.

16. That the sovereignty of the citizens of the Ecuadorian State be respected, in the face of the impositions of the W.H.O. and other global entities, and, if necessary, that our country withdraw from said organizations.

We send to you, Mr. Engineer Daniel Noboa Azín, in your capacity as Constitutional President of the Republic of Ecuador, this **MANDATE OF THE SOVEREIGN PEOPLE OF ECUADOR** for the pertinent said legal purposes, leaving the sole and exclusive responsibility of your authority to comply with this document.
