- 3. **Global transformation** is a chance for renewal and progress grounded in our common humanity. Advances in knowledge, science, technology, and innovation could deliver a breakthrough to a better and more sustainable future for all. **[Global transformation is good]**
- 4. **We believe there is a path to a brighter future for all of humanity**, including those living in poverty and vulnerable situations. Through the actions we take today, we resolve to set ourselves on that path, striving for a world that is safe, peaceful, just, equal, inclusive, sustainable and prosperous, a world in which human wellbeing, security and dignity and a healthy planet are assured. **[We promise you heaven]**
- 5. **This will require a recommitment to international cooperation based on respect for international law...** **[But only if everybody obeys]**

- 9. We also reaffirm that the **three pillars** of the United Nations – **sustainable development**, **peace and security**, and **human rights** – are equally important, interlinked and mutually reinforcing. We cannot have one without the others. **[This is a lie. Development was one of the original pillars, not sustainable development.]**
- 10. We recognize that **sustainable development** in all of its three dimensions is a central goal in itself and that its achievement, leaving no-one behind, **is and always will be a central objective of multilateralism. [Did you vote for this?]**
- **11.** We reaffirm the Paris Agreement temperature goal of holding the increase in the global average temperature to well below 2 degrees Celsius above pre-industrial levels and pursuing efforts to limit the temperature increase to 1.5 degrees Celsius above pre-industrial levels... **[The US Senate never ratified this agreement so its enforcement is questionable]**

- 17. We will advance implementation of these actions through relevant, **mandated intergovernmental processes**, where they exist. **[If we can force this on you, we will!]**
- 18. In 2015, we resolved to free the human race from the tyranny of poverty, hunger and want and to heal and secure our planet... the achievement of the Sustainable Development Goals is in peril. **Progress on most of the goals is either moving too slowly or has regressed below the 2015 baseline. [So despite UN efforts the SDGs went backwards...and now we must pay for the UN's and governments' failures?]**
- 19. **We reaffirm that the 2030 Agenda for Sustainable Development is our overarching road map for achieving development** in all three of its dimensions, overcoming the multiple, interlinked crises we face and securing a better future for present and future generations. **[The Agenda that has so far failed must be our roadmap for the future.]**

- 23. (i) Promote inclusive and effective international tax cooperation, which contributes significantly to national efforts to achieve the Sustainable Development Goals, as it enables countries to effectively mobilize their domestic resources and stress that the current international tax governance structures need improvements. We are committed to strengthening the inclusiveness and effectiveness of tax cooperation at the United Nations, while taking into consideration the work of other relevant forums and institutions, and will continue to engage constructively in the process towards developing a United Nations framework convention on international tax cooperation. **[Countries should work together to extract more taxes from their citizens, which can then be spent to achieve the SDGs.]**
- 24. We are committed to a rules-based, non-discriminatory, open, fair, inclusive, equitable and transparent multilateral trading system, with the World Trade Organization (WTO) at its core. **[We will continue to use the WTO rules to create an unequal playing field in which the developing nations keep being shafted.]**

- 25. (e) Maximize the positive contribution of migrants to the sustainable development of origin, transit, destination and host countries and strengthen international partnerships and global cooperation for safe, orderly and regular migration to comprehensively address the drivers of irregular migration and ensure the safety, dignity and human rights of all migrants, regardless of their migration status. **[It is difficult to understand this gobbledygook, except that it promotes migration.]**
- 27. (f) **Ensure universal access to sexual and reproductive health** and reproductive rights as agreed in accordance with the Programme of Action of the International Conference on Population and Development and the Beijing Platform for Action and the outcome documents of their review conferences. **[Ensure widespread use of abortion, birth control and vaccines for STDs: monkeypox, HPV (Merck's Gardasil) and Hepatitis B, all dangerous, and any others still in development.]**

- 28. **We decide to:**
- (a) Welcome the decisions adopted at the twenty-eighth session of the Conference of the Parties to the United Nations Framework Convention on Climate Change, including the decisions adopted under the “UAE Consensus” that includes the outcome of the first global stock-take of the Paris Agreement, at the fifth session of the Conference of the Parties serving as the Meeting of the Parties to the Paris Agreement. **[Deliberate obfuscation.]**
- (c) Come forward in our next nationally determined contributions with ambitious, economy-wide emission reduction targets, covering all greenhouse gases, sectors and categories and aligned with limiting global warming to 1.5 °C, as informed by the latest science, in the light of different national circumstances, while reaffirming the nationally determined nature of nationally determined contributions and **in line with article 4 of the Paris Agreement. [Impossible to know what this means.]**
- (h) **Protect everyone on earth through universal coverage of multi-hazard early warning systems by 2027**, including through the accelerated implementation of the Early Warnings for All initiative. **[You have got to be kidding.]**

- **29.** (a) Achieve a world in which humanity lives in harmony with nature **[Sure.]**
- (c) Promote sustainable consumption and production patterns, including sustainable lifestyles, and circular economy approaches as a pathway to achieving sustainable consumption and production patterns, and zero waste initiatives. **[The peasants must get less, and garbage must be consumed.]**
- (e) Deliver on our agreed commitments to halt and reverse biodiversity loss by 2030 and **implement all multilateral environmental agreements. [Natura 2000 and 30x30 must be fully implemented, as well as other environmental agreements, so governments take over private land and water.]**
- **35.** (g) Redouble our efforts to end impunity and ensure accountability for atrocity crimes and other gross violations, such as the use of starvation of civilians as a method of war **[Gaza efforts?]**
- (h) Commit to support timely and decisive action, in particular by the Security Council and General Assembly, aimed at preventing and ending genocide, war crimes, crimes against humanity and the crime of aggression. **[Where are these actions today?]**

- 39. (g) Address the risks to sustaining peace posed by disinformation, misinformation, hate speech and content inciting harm, including content disseminated through digital platforms, while respecting the right to freedom of expression and to privacy and ensuring unhindered access to the internet in accordance with international law, domestic legislation and national policies. **[Dangerous doubletalk regarding censorship.]**
- 42. (b) Urgently implement agreed commitments on climate change, the environment, and sustainable development, within the respective mandate of each intergovernmental organ, including financial commitments to support developing countries, especially those that are particularly vulnerable to the adverse effects of climate change.

- 45. (a) Implement a whole-of-government and whole-of-society approach to prevent and combat terrorism and violent extremism conducive to terrorism, including by addressing the drivers of terrorism, in accordance with international law. **[This is US government terminology, revealing authorship of at least this section.]**
- 47. (a) Recommit to the goal of the total elimination of nuclear weapons in the context of general and complete disarmament under strict and effective international control. **[The UN cannot manage nuclear disarmament; only the major nuclear nations have the capability to detect cheating and obtain compliance.]**
- 48. (c) Address emerging and evolving biological risks through improving processes to anticipate, prevent, coordinate and prepare for such risks, whether caused by natural, accidental or deliberate release of biological agents. **[Comply with the Biosecurity Agenda.]**

- **54.** (a) Foster and promote an open, fair and inclusive environment for scientific and technological development and cooperation worldwide, including through **actively building trust in science** and global collaboration on innovation. **[Trust the science.]**
- (c) **Encourage talent mobility and circulation**, including through educational programs, and support developing countries to retain talent and **prevent a brain drain** while providing suitable educational and working conditions and opportunities for the workforce. **[More doubletalk.]**
- **56.** We decide to: (a) Protect and **enforce intellectual property rights** to promote technological innovation, build trust and contribute to the transfer and dissemination of technology on mutually agreed terms. **[While promising developing nations technology will help them, we share no intellectual property. More doubletalk. Bill Gates is satisfied.]**

- **Action 33.** We will ensure that science, technology and innovation contribute to the full enjoyment of human rights by all. **[Preserving intellectual property rights is followed by Action 33, an apparent contradiction.]**
- **57.** We decide to: (a) Ensure that all scientific and technological research is conducted in a responsible and ethical manner that protects and promotes all human rights, and **protects the autonomy, freedom and safety of scientific researchers.** **[Is this a nod toward promoting freedom to perform GOF or other objectionable research?]**
- **63.** (b) Accelerate efforts to achieve universal health **coverage** to ensure all young people enjoy the highest attainable standard of physical and mental health, including **immunizations and vaccinations and sexual and reproductive health,** and address all the challenges faced by developing countries to achieving these goals. **[What the UN and WHO want is to vaccinate and provide birth control. Vaccination is paramount to the Great Reset.]**

- **Action 41.** We will transform global governance and reinvigorate the multilateral system to tackle the challenges, and seize the opportunities, of today and tomorrow. **[We WILL transform the way you are governed]**
- **Action 48.** We will strengthen the United Nations system **[Centralizing power]**
- **Action 50.** We will accelerate reform of the international financial architecture to address the challenges of today and tomorrow... The reform of the international financial architecture should place the 2030 Agenda at its centre... **[The transformation of the entire world's financial system will be focused on achieving the Sustainable Development Goals.]**

- **Action 57.** We request the Secretary-General to: Present for the consideration of Member States protocols for convening and **operationalizing** emergency platforms based on **flexible approaches** to respond to a **range of different complex global shocks**, including **criteria for triggering** and phasing out emergency platforms. **[The S-G will decide what is an emergency, when to trigger one, and how to manage it.]**
- **Action 58.** We will strengthen international cooperation for the environment and the **implementation** of and **compliance** with our multilateral environmental agreements to deliver on our ambition to protect our planet. **[Nations MUST comply with environmental dictates]**
- **Action 59.** Deepen United Nations' engagement with national parliaments in United Nations intergovernmental bodies and processes, in accordance with national legislation, including through building on the efforts of the United Nations and Inter-Parliamentary Union to **engage parliamentarians to maintain support for the implementation of relevant UN agreements and resolutions.** **[Nations must implement UN agreements in domestic law.]**
