

**Lawsuit**: Dustin Kittle and Ashley Posey - Highlighting the lack of federal oversight over 46% of U.S. farm debt.

**Foreclosures** - Increasing risk for farmers due to financial instability.

**Liquidity Deficits** - Limited cash flow leading to financial challenges



#### The Farm Credit Adminstration

Foreign Purchases and Corporatism - From rural broadband to CO2 sequestration pipelines, outside influence grows.

Farm Losses - 27k-30k farms lost annually.

**Redistricting and Loss of Representation** - Shrinking political influence for rural communities.

March 7, 2024: H.R. 7521 passes the House after rules are suspended.

H.R. 7521: Linked to \$95 billion in proxy war spending.



## IEEPA and the TikTok Ban: Proxy Wars and Power Shifts

**July 22, 2024:** Biden delegates authority as POTUS to the Treasury.

**Konstantin Malofeyev:** U.S. transfers forfeited Russian funds to Ukraine, with more expected.

Pavel Durov, Elon Musk: Notable figures involved.
